Eating Meals in Dining Room	All Ages	None Required	<ul style="list-style-type: none"> <li>• Accident from fall, trip, slip.</li> <li>• Accident from misbehaviour.</li> </ul>	<ul style="list-style-type: none"> <li>• Students must behave in a quiet &amp; orderly manner when entering &amp; exiting the dining room.</li> <li>• Students should remain seated during meals &amp; keep movement to a minimum.</li> <li>• Noise should be kept to an acceptable level to allow the delivery &amp; receiving of instructions.</li> <li>• Teaching staff/supervisors should keep the movement of students orderly. We recommend that a maximum of two tables of students be standing at meal service area at one time.</li> <li>• Each student should be responsible for their own crockery &amp; cutlery thus placing these in the appropriate area at the end of the meal.</li> <li>• Each table of students will be responsible to leave their area clean &amp; tidy.</li> </ul>

Eating Meals in Dining Room	All Ages	None Required	<ul style="list-style-type: none"> <li>• Allergic reaction from Food.</li> </ul>	<ul style="list-style-type: none"> <li>• Students with Food Allergies must be advised to the Camp Management 14 days prior to arrival.</li> <li>• A detailed description of Allergies must be provided along with the students' name and photograph.</li> <li>• Parents/Guardians of students with food allergies should be advised to contact the Camp to discuss the suitability of foods being served.</li> <li>• Students with Allergies must be made aware that they may be receiving a different meal and to make themselves known to kitchen staff.</li> <li>• Students with severe Allergies or Allergies to food vapours may be required to eat in a separate area.</li> <li>• Teaching staff/supervisors must supervise students during service &amp; ensure students with Allergies do not eat or come into contact with something unsuitable.</li> <li>• Teaching staff must ensure students required to carry Allergy Medication must do so at all times.</li> <li>• Teaching staff should all be trained in the administration of Allergy Medications carried by students.</li> </ul>
